

1773, June 27 Selectmen to Council advice regarding possible penalties for people going to Pest Island without inoculations for small pox, Sam Cutts, George Hart and George Gains [NHSP, XIII, pg.. 278]

Jan. 3, 1775 - G. Gains to Samuel Cutts re blankets to be sent to Exeter

May 23, 1775 – Committee of Safety in Ports. Re: prisoner of war, Jonathan Akerman, to be guarded until examination tomorrow, signed by Neal McIntyer, Secretary

May 24, 1775 – Meeting of Committee of Safety re: Jonathan Akerman spying for the British

Aug. 23, 1775 - Committee of Safety suggestions for fortifications and armaments for Seavy Island, Pierce's Island John Langdon Island and Church Hill, includes inventory of cannons & stores.

Aug. 25 1775 – Committee of Safety letter to Congress, HMS Ship's Scarborough and Canso sailed from Portsmouth to Boston with Governor Wentworth & family [NHSP XIII, pg. 279]

### Fld 4 Portsmouth 1775 (17 items) Continued

Aug. 25, 1775 – H. Wentworth, chairman, Committee voted that application be made to the Provincial Congress for "Liberty to ship off fish" until 10<sup>th</sup> Sept.

Aug. 31, 1775 - Complaint regarding forcible entry and destruction of Moses Woodward's billiard table and his pregnant wife endangered.

Oct. 7, 1775 - Ship Prince George, Richard Emms, Master, loaded with 1, 892 barrels of flour for General Gates forces was boarded & possession taken by Lt. Thomas Pickering. – it was then unloaded & suggested that the cargo be sold to supply the fort. The Committee of Safety wrote to George Washington and he requested all the flour be sent to him for the army. The final decision was that 600 barrels be kept for Portsmouth. Concerned about bombardment, so request made for 44 men for the Fort at Seavy's

Oct 9, 1775 - Committee of Safety requested 200 men officered and equipped for the batteries in case the British fleet comes to Portsmouth

Island. John Penhallow, John Wendell & George King on behalf of the Committee

Oct. 11, 1775 - Letter from Joseph Reed, Sec. To General Washington. Wants flour, no answer from the Provincial Committee yet re: flour. Order of the Committee of Safety to give 1,292 barrels to Mr.Maylan, Muster Master for Washington. Supply Clap, Secretary. Gookin, Joshua Wentworth, Samuel Sherburne, Pearse Long, George Wentworth assigned as committee to assist Mr. Maylan.

Oct. 17, 1775 - Governor's pass to James McMasters

Nov. 4, 1775 - Pass for George Boyd to go to Great Britain

Nov. 9, 1775 - Committee of Safety petition to the Provincial Congress re: men & ammunition to defend Portsmouth [NHSP, XIII, pg. 279-280]

Nov. 13, 1775 - Committee of Safety to the Congress of the Colony requesting recompense for Hall Jackson' services as surgeon to the army [NHSP, II pg. 201 & NHPP VII, pg. 654]

Nov. 14, 1775 - Printed document, ordering selectmen to notify inhabitants to elect three persons to represent them at a general Congress at Exeter, Dec. 21. Matthew Thornton President. Manuscript note, that Sam Cutts, Samuel Sherburne & Capt. Pearse Long were chosen. Signed by George Gains and George Hart.

Nov. 22, 1775 -- Voted that Capt. Thomas Thompson's letter re: state of the fire rafts be referred to the Colony Committee of Safety.

### Fld 4 Portsmouth 1775 (17 items) Continued

Nov. 22, 1775 - Committee of Safety voted to prevent George Meserve from reaching Boston [NHSP, VII, pg. 673]

Dec. 16, 1775 - Committee of Safety thinks it imprudent to to let Capt. Emmes take passage to the West Indies. A sum should be allowed for board from when he was discharged from the ship *Prince* until he leaves the province.

Dec. 19, 1775 - Town meeting voted that Sam Cutts, Capt. P. Long & Samuel Sherburne appointed as delegates from Portsmouth to Exeter to the Colony Congress.

### Fld 5 Portsmouth 1776 (8 items)

Jan. 10, 1776 - John Penhallow, Chairman to the Committee of Safety at Greenland. The Town had forwarded a petition to the Provincial Congress asking them to "defer taking up government" avoid making enemies of friends in Great Britain and endanger the common cause. [NHSP, VII, pg. 16-17]

Jan. 12, 1776 - Town meeting resolving to write Congress re anonymous letter from Portsmouth [NHSP, VIII, pg. 15]

Jan. 15, 1776 - Town meeting voted to send John Pickering, Col. Joshua Wentworth & John Wendell to Exeter in support of town's petition [NHSP, VIII, pg. 17]

July 12, 1776 - John J. Bartlett, chairman of the Committee of Correspondence for Kittery to the committee of Correspondence in Boston, orders that no boat or vessel be suffered to leave town without permission or be allowed to fish more than one league for shore, to prevent communications with the British [NHSP, VIII, pg. 363]

July 31, 1776 - Meeting, J. Penhallow, town clerk on holding office in government & instructions from the town to their representatives

Sept. 30, 1776 – M. Weare, President, printed & signed notice to selectmen of Portsmouth to elect three persons to represent them in the Assembly at Exeter

Dec. 18, 1776 - Town meeting: instructions from town to their representatives, re: an act of assembly, need of the soldiery are not neglected, needs of poor, widows, etc., currency representation, and other matters. [NHSP, XIII, pg. 281-283]

Dec. 20, 1776 - John Langdon speaker to Governor and Proprietors of the State to Selectmen of Portsmouth re: resignation of John Pickering as representative, a new person must be chosen. Note: Thomas Martyn chosen Jan. 7, 1777

### Fld 6 Portsmouth 1777-1813 (16 items)

- Jan. 6, 1777 Town meeting, instructions to John Langdon, George Gains & Thomas Martin, Representatives of Portsmouth, to try to convince the General Assembly to start meeting again at the Portsmouth State House.
- Feb.3, 1777 Committee of Safety, H. Wentworth, Chairman, send Thomas Hart & Supply Clap(p) to Exeter to meet with State Committee of Safety.
- May 15, 1777 Committee of Safety have no objection the *Schooner McClary*, Thomas Dalling, Commander, sailing on a cruise. Samuel Penhallow, Chairman, George King, George Gains, & John Fernald, Selectmen.
- June 10, 1777 Town meeting, instructions to John Langdon, George Gains & Thomas Martin, Representatives of Portsmouth, to urge the Assembly to pass an act to have all people swear allegiance to the State, those who would not the oath "should be secured as prisoners of war"
- June 28,1779 Inhabitants alarmed by enemy at coast of Massachusetts Bay and want to supply assistance to Massachusetts. Propose to send *Ship Hampden* be commissioned, fitted and manned by volunteers. Signatures of 50 townsmen. [NHSP, XIII, pg. 285]
- June 13, 1780 Town to House of Representatives at Exeter. Complaint concerning heavy taxes; description of loss of shipping revenue from 12,000 tons in 1774 & other damages. John Penhallow, Town clerk
- Nov. 27, 1780 Instructions to William Whipple, John Langdon & George Gaines to support fair and punctual payment for officers and sailors; failure of paper currency and suggestion to enact new laws to give credit and permanency to currency; not to consent to embargoes in trade between states.
- Dec. 14, 1781 Printed signed M. Weare President and John Langdon Speaker to meet to elect three representatives to general Assembly
- Nov. 18, 1782 Proceedings of town meeting, Jeremiah Libbey, Town Clerk. Requests repeal of oath as pertains to voters in town and parish officers
- Oct. 23, 1783 Representatives of Town of Portsmouth recommended to oppose making an alteration to the 8<sup>th</sup> article of confederation
- June 1, 1786 Council file, letters received at post offices & sent to Portsmouth Mar-July

April 8, 1791 - Town meeting voted New Castle lottery injurious to the morals of the people; requested managers of lottery to remove their office from Portsmouth & apply to the General Court to prevent the lottery from being managed in a manner hurtful to the interests of the people. John Evans

Dec. 12, 1798 - Bridge income statement, sworn by Thomas Martin, Treasurer

Aug. 2, 1813 - Town meeting voted to request the Governor to furnish out of public stores 250 of powder, 3000 flints & a quantity of balls for the defense of the town & harbor plus suitable watch & guard, cannons & artillery; erect battery; build suitable platforms & mount the cannon. Joseph Seaward, Town clerk

May 4<sup>th</sup>, 1847 - Deed Alfred Dennett of Portsmouth to Thatcher Emery for land and building at Water Street 7 School Street.

1976 - Map of Greenland & Portsmouth line [filed in Map drawer 34, folder 4 in vault]

Undated - A list of the poor & their condition, dependent on the town of Portsmouth for their support including names and age and/or handicap, n.d.

Undated - Portsmouth selectmen regarding a bill to establish a market house and hire a clerk annually to supervise quality and sale of provisions.
