Commencing June 7<sup>th</sup> 1834

[p. 2] Portsmouth June 7<sup>th</sup> 1834 – Mr. Joseph Tilton and Miss. Fanney Willey were duly married by me this day, both of Exeter – John Bennett, Justice of the Peace

Portsmouth August 17<sup>th</sup> 1835 – Mr. William Moses and Miss. Clarisa Waterman were duly married by me this day, both of Portsmouth - John Bennett, Justice of the Peace

Portsmouth September 25<sup>th</sup> 1836 – Mr. Abraham Q. Wendell and Miss Olivia Simes were duly married by me this day, both of Portsmouth - John Bennett, Justice of the Peace

Portsmouth December 17<sup>th</sup> 1837 – Mr. John A. Johnson and Miss Margaret Pitman, both of said Portsmouth, were joined together in marriage by me this day - John Bennett, Justice of the Peace

Portsmouth October 9<sup>th</sup> 1839 – Mr. Patrick McGinnis and Miss Margaret Orake [or Drake], both of said Portsmouth, were joined together in marriage by me this day - John Bennett, Justice of the Peace

[p. 4] Portsmouth November 15<sup>th</sup> 1839 – George Barker and Rachel Fogg, persons of color, both of said Portsmouth, were duly joined together in marriage by me this day - John Bennett, Justice of the Peace

Portsmouth May 16<sup>th</sup> 1841 – Mr. Benjamin D. Loughton and Miss Susan W. Resnick, both of said Portsmouth, were joined together in marriage by me this day - John Bennett, Justice of the Peace

[p. 5] Portsmouth April 7<sup>th</sup> 1845 – Mr. Thomas Wood and Miss Barbara Stevenson, both of Portsmouth, were joined in marriage by me this day - John Bennett, Justice of the Peace

April 29<sup>th</sup> 1845 – Then personally appeared Samuel Donnell and took an Oath of Allegiance and Oath of Office as Lieutenant in the 2<sup>nd</sup> Company of Infantry in the 1<sup>st</sup> Regiment of Militia in the state of New Hampshire before me - John Bennett, Justice of the Peace - Made return October 1<sup>st</sup> 1845

[p. 6] May 15 1845 - Then personally appeared Samuel G Folsom and took the Oath of Allegiance and Oath of Office as a Captain in the 2<sup>nd</sup> Company of Infantry in the 1<sup>st</sup> Regiment NH Militia before me - John Bennett, Justice of the Peace – made return October 1<sup>st</sup> 1845

May 20<sup>th</sup> 1845 – Then personally appeared Albert Hayes and took an Oath of Allegiance and Oath of Office as Captain of the 5<sup>th</sup> Company of Infantry in the 1<sup>st</sup> Regiment of NH Militia before me - John Bennett, Justice of the Peace – made return October 2<sup>nd</sup> 1845

October 2<sup>nd</sup> 1845 – Then personally appeared Joseph H Franklin and took the Oath of Allegiance and the Oath of Office as Ensign of the 2<sup>nd</sup> Company of Infantry in the first Regiment of Militia in New Hampshire before me - John Bennett, Justice of the Peace

[p. 7] September 28<sup>th</sup> 1846 – Mr. Daniel Hawthorn and Miss Bridget Cassidy both of said Portsmouth were joined in marriage by me this day - John Bennett, Justice of the Peace

May 11<sup>th</sup> 1847 – Charles W Marden thus personally appeared and took the Oath of Allegiance and the Oath of Office as Ensign of the 3<sup>rd</sup> Company of Infantry in the 1<sup>st</sup> Regiment of Militia in the state of New Hampshire before me - John Bennett, Justice of the Peace

[p. 8] May 10<sup>th</sup> 1848 – Samuel Donnell then personally appeared and took the Oath of Allegiance and Oath of Office as Captain of the 2<sup>nd</sup> Company of Infantry in the first Regiment of Militia in the state of New Hampshire before me - John Bennett, Justice of the Peace

May 13<sup>th</sup> 1848 – Wingate N Ilsley then personally appeared and took the Oath of Allegiance and Oath of Office as Ensign of the 3<sup>rd</sup> Company of Infantry in the first Regiment of Militia in the state of New Hampshire before me - John Bennett, Justice of the Peace

[p. 9] May 15<sup>th</sup> 1848 – Ezra A. Stevens then personally appeared and took the Oath of Allegiance and Oath of Office as Ensign of the second Company of Infantry in the first Regiment of New Hampshire Militia before me - John Bennett, Justice of the Peace

May 15<sup>th</sup> 1848 – John Dame then personally appeared and took the Oath of Allegiance and Oath of Office as 1<sup>st</sup> Lieutenant of the third Company of Infantry in the 1<sup>st</sup> Regiment of Militia in New Hampshire before me - John Bennett, Justice of the Peace

[p. 10] May 16<sup>th</sup> 1848 – Charles W Marden then personally appeared and took the Oath of Allegiance and Oath of Office as 2<sup>nd</sup> Lieutenant of the 3<sup>rd</sup> Company of Infantry in the first Regiment of Militia in New Hampshire before me - John Bennett, Justice of the Peace

March 3<sup>rd</sup> 1849 - Ezra A. Stevens then personally appeared and took the Oath of Allegiance and Oath of Office as a Lieutenant on the 2<sup>nd</sup> Company of Infantry of NH Militia before me - John Bennett, Justice of the Peace

April 26<sup>th</sup> 1849 – Charles W Marden then personally appeared and took the Oath of Allegiance and Oath of Office as 1<sup>st</sup> Lieutenant in the 3<sup>rd</sup> Company of Infantry in the first Regiment of New Hampshire Militia before me - John Bennett, Justice of the Peace

[11] April 26<sup>th</sup> 1849 – Then Wingate N Ilsley personally appeared and took the Oath of Allegiance and Oath of Office as a 2<sup>nd</sup> Lieutenant in the 3<sup>rd</sup> Company of Infantry in the first Regiment of New Hampshire before me - John Bennett, Justice of the Peace

April 29<sup>th</sup> 1849 – Then Charles L Donnell personally appeared and took the Oath of Allegiance and Oath of Office as Ensign of the second Company of Infantry in the first Regiment of New Hampshire Militia before me - John Bennett, Justice of the Peace

[p. 12] Rockingham Co. Portsmouth June 19<sup>th</sup> 1850 – Then personally appearing Mr. Wright Bancroft and Miss Hannah Cartledge both of said Portsmouth and were lawfully joined together in marriage by me - John Bennett, Justice of the Peace

Mr. Bancroft is 29 years of age born in England

Miss Cartledge is 25 years of age born in England

Rockingham Co. Portsmouth October 1<sup>st</sup> 1850 – Mr. John E. Trefethen of Medford Mass. and Miss Emely A. Bruce of said Portsmouth personally appearing on this day and were lawfully joined in marriage by me - John Bennett, Justice of the Peace

[Ichabod] Barttell Claggett he being sick and unable to attend to the case it was by a written agreement of the attorney to the parties brought before me John Bennett a Justice of the Peace this the 7<sup>th</sup> day of October AD 1859 at the office of Sam H Goodall in Portsmouth at 10AM – In a plea of trespass which is set forth in the writ on file. After hearing the evidence of the pltf [plaintiff] as well as the defd.[defendant] it is counselled by me said Justice that the defd. is guilty as charged in the third court [or count] and that the plaintiff Levi Gilson recover of the defd. five dollars & pay costs amounting to seven dollars and seventy one cents - John Bennett, Justice of the Peace.
