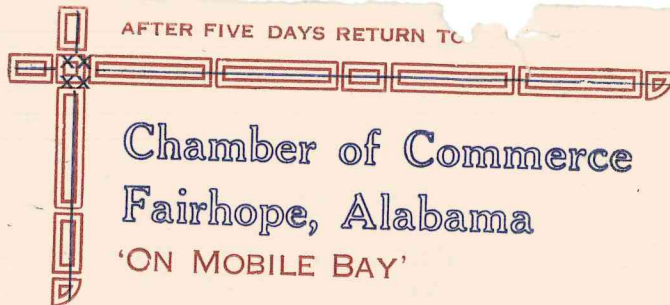

Dear Mr. Bennett:

At the last meeting of our Executive Council bills were presented from the Fairhope Coal & Supply Co and from J. T. Bradford for materials supplied the school for fencing which we had authorized.

These bills were held up for investigation since they appeared to be unduly large for the approximately 110 ft. that we had considered. I came by the grounds while school was in session and saw that the fence had been extended north from our corner for a considerable distance, greater in fact than the distance along our line.

Was there a misunderstanding in this matter? and did you understand that our agreement was to pay for all the fencing or do ~~have~~ you have funds from which to pay for that portion extending north from our west corner?

The Fairhope Coal & Supply Co. Bill is for 330 ft. of fencing 3 times the amount we had considered and is for \$13.52, one-third of which would be \$4.51. The Bradford bill is for 30 7 ft. posts and for 2 10 ft. posts and assuming that the two ten foot posts and 10 of the 7 ft. posts were needed on our line, our portion of the total bill of \$5.76 would be \$2.58.

Please let me hear from you on this matter. Our next meeting is Thursday, the 18th.
