

REGULATIONS REGARDING COLLECTION OF BOX RENT

Collections shall be made on or before the beginning of a quarter for the entire quarter or in advance for the current fiscal year. Box patrons and agencies of the Federal Government are permitted to pay rental on post office boxes in advance for not more than one full fiscal year, July 1 to June 30, next, or for the quarters remaining in the fiscal year. When a patron, including Government agencies, surrenders a box prior to the expiration of the period for which rental has been paid, no portion of the rental shall be refunded. When a box is rented after the beginning of a quarter, rent must be collected pro rata for the remainder of the quarter, except that rental for the entire quarter should be collected from a box holder who pays for the right to continue the use of a box which he held during the previous quarter. If a box holder fails to renew his right to his box on or before the last day of the period for which rented, the box shall then be closed and offered for rent and the mail placed in the general delivery, unless deliverable by carrier.




