Mr. Patterson presented to the Council last night the petition for referendum election handed him by you and the Council voted to call the election, as prayed for, on June 1, 1929.

I am instructed however, by President Call, this morning, to notify you that two more names will be required to constitute certainly, under the existing enrollment of members who would be entitled to vote on the question ansa if "on the Corporation ground on the day of election" (and there is no way of telling in advance who, or now many, may avail themselves of the privilege) the "ten per cent of the qualified membership" required by Sec. 1, Art. VI, entitled to call for a referedum. These you can, of course, easily seeme and I am returning the petition for you to have the two additional signers added thereto.

I am directed also to call your attention to the fact that, while your petition calls for "ail acts and notices necessary for hodding of said election as required by law and the constitution and by-laws of the Corporation be some and given by executive council of this corporation" that such necessary acts for the carrying out of the will of the petitioners development the constitution upon the trustees. However, the Council in its motion calling the election, referred such duties to the Trustees.

Honorable Mayor and Town Council, Town of Fairhope,

Gentlemen: -

At the regylar meeting of Executive Council this Corporation, Monday evening, 20th, the request of your committee, Messrs Baldin and Gaston, was received for ten feet from the land of the Corporation, ton the west side of Section St., to widen that street from Fairhope Ave. to the cemetery. By motion duly made, put and carried, the Council expressed its approval of the proposed widening that as fast as the Town was ready to pay the damages sustained by lessees of the Corporation, on account of such widening, the Corporation would exercise the right of eminent domain reserved in its leases to take possession of the needed land for public purposes; such purpose being to place it in the hands of the Town.

At the same meeting inconsultation and agreement with Mrs. V.E.duChoine, it was decided, subject to approval of the town to change the alley running north and south across block four, div. 3, of the Corporation land, to run north from the point where this alley sauth in the center of the block turns at an angle northeastward, to terminate on the north side of the block at the point where it originally terminated. Several years ago a change in this alley from the line shown on the plat, to line as indicated on sketch accompanying this was agreed to by the then Council, reserving the right at any time to enter upon the original alley for the purpose of maintaining or replacing the water main laid therein. The line then agreed upon and the line now desired are indicated on the sketch.

The officers of the Corporation have received many complaints of the condition of Nichols St., west of Mobile Avenue, which they consider to be a street, from Mr. Hemley, and hope that the town will find itself able to give Mr. Hemley relief, The present condition is understood to be largely because of the Town running a ditch on the north side of the street fro drainage purposes, and from time to time digging the sand out of same and throwing it either along the sidewal space or outward from the line. If there is any question of the town as to the dedication of this street by the S.T.Corporation it will be glad to take the matter up with the Town, the writer is sure.
