Dear Mr. Larkin:-

I wrote you Sept. 10th that , hoped to make you a proposition for settlement with regard to your surrendered land here which I hoped would be satisfactory. The sterm hit us on our meeting night in September and we were all so busy following the strom that we failed to hold the usual second meeting in the month.

At our meeting last night I got attention to the matter with result that I was authorized to make you a proposition to allow you the amount set by the committee for the trees on the portion surrendered plus the clearing at \$25 an acre, \$126 for trees, 4.66 acres at \$25, ar \$116.50, total \$242.50, to be credited on your rent account. Our superintendent of lands and highways says he asked two or three disinterested and informed persons as to the value of the fence, and they said they did not consider it worth anything, which conformed to his own judgment. So many of the posts are rotten and the wires so badly rusted, that no one who would want a fence in front of any part of the property would give anything for it, according to him.

Rent was of course stopped at the time you surrender this part of the la d on the portion surrendered, but that did not cancel the rent alr ady accrued.

This proposition is for prompt acceptance and is departing from our we al rules, because we would like to have the lad available for people who would like a lot or so in that locality. I hope on this account that it will be accepted.

A pretty good demonstration of the practicality of the Single Tax is afforded by the fact that with renta for it land so much more attractive than buying in the usual way, that 4/5 of the population is on the enc-half of the land which the Colony owns; that all hotels and all business houses with two uninimportant exceptions, are on its land; that almost all of the improvements now in progress are on its land; and yet that after paying for its lesses state, county and town tax on land and their improvements and personal property held thereon, it has such a cash balance, while the town will be out of funds until tax payments come in in December, except for receipts of municipal public service plant.

You are probably familiar with the Single Tax in general but I am also including the The Single Tax, What It Is and Why We Urge It " by Henry George, as republished in the Congressional Record some years ago, and also a republican in the Record, by Senator Lynn J. Frasier, of N.D., of an extract from the later Herbert Quick's book, "The Real Trouble With the Farmers."

I hope you will find the matter of interest and giving you the information you desire and will be glad to serve you in any other way I can.

# ROBERT SCHALKENBACH FOUNDATION MEETING OF MEMBERS

#### MINUTES

A stated meeting of the Members and Directors was held at the Engineers' Club, 32 West 40th Street, New York City, on October 13, 1926, at 12:30 o'clock P. M. pursuant to notice duly sent to each member. There were present Messrs. Brown, Ryre, Fairchild, Hall, Hennessy, Ingersoll, Leubuscher, Miller, Murphy, Pleydell, Polak, Post, Purdy, Rusby, Schalkenbach, Stephens. There were absent: Messrs Allen, Cohen, Moody, Root and Seabury.

Mr. Eyre presided as chairman and Mr. Fairchild acted as secretary of the meeting.

Mr. Eyre explained that Mr. Root had been called away to Florida most unexpectedly, and that he had been requested to conduct the meeting in Mr. Root's absence.

The secretary presented a letter from Mr. E. Yancy Cohen, stating that he would be unable to attend the meeting. Mr. Post stated that Mr. Moody sent his regrets that he could not attend the meeting.

- 1. The minutes of the last meeting, held May 11, 1926, were read. Upon motion by Mr. Stephens and seconded and carried, the minutes were ordered amended by inserting therein the quotation from Henry George which was read at the last meeting by Mr. Stephens. The minutes were otherwise approved.
- 2. The treasurer presented his report for the period from May 6, 1926 to October 13, 1926. The report showed a balance on hand October 13, 1926, in the income account of \$1,132.66. The treasurer also reported that the sum of \$78,000.00 had been received on account of principal from the estate of Robert Schalkenbach, which had been

invested in First Mortgage bonds guaranteed at 51%. Upon motion duly made, seconded, and carried, the treasurer's report was approved and ordered filed with the minutes.

3. Mr. Leubuscher stated that as Executor of the Estate of Robert Schalkenbach, he expected to be able to pay over the balance of the residuary estate about January 1, 1927, and that there would be included an accumulation of income which he roughly estimated would be about \$6,000.00 or upwards. Upon motion made by Mr. Purdy, and duly seconded and carried, it was,

RESOLVED, that the Executive Committee be instructed to treat the surplus income accumulated in the hands of the Executor as a reserve fund.

- 4. The chairman called upon Mr. Charles Johnson Post who reported upon the publicity propaganda to date. He reported that an interview with Mr. Root had been sent out by the Consolidated Press to over 155 newspapers with an aggregate circulation of 8,000,000 copies daily. That another interview with Mr. Root for release October 26th, which was the climax of a series of three interviews on taxation, would be sent out by the United Publishers Syndicate covering approximately 50 papers and with an aggregate daily circulation of 3,000,000 copies. He reported that he had formed the "American Association for Scientific Taxation" for supplying the business and trade periodicals with bulletins and articles on taxation. That out of a list of 1760 of these periodicals he had received 223 requests for a continuance of this service of tax articles and bulletins. This represented a circulation per issue of approximately 800,000 to 1,000,000 copies per issue.
  - 5. Mr. Ingersoll spoke briefly in commendation of the work

done by, and results accomplished by Mr. Post, and expressed his opinion that this form of publicity should be continued. A general discussion of the subject followed.

Upon motion made by Mr. Purdy and seconded by Mr. Brown, and unanimously earried, it was,

RESOLVED, that it is the sense of this meeting that the work done by Mr. Post so far as he had gone and as outlined by him, be approved and continued.

At this point Mr. Ingersoll, Mr. Hall and Mr. Stephens, after recording their vetes in favor of the foregoing resolutions, were excused from the meeting because of other appointments.

6. The Chairman brought up the subject of the book proposed to be published by the Vanguard Press, the text of which has been prepared by Mr. Louis F. Post under the title, "What does the Single Tax Mean?" The Chairman stated that this matter had received the consideration of the Executive Committee, and the publication of the book had been approved by the Executive Committee, but that it was the feeling of the Executive Committee that this subject was of such importance that the approval by the full Board of Directors was desired.

Upon motion by Mr. Purdy, seconded by Mr. Polak, and unanimously carried, it was,

RESOLVED, that the Robert Schalkenbach Foundation regards Mr.

Louis F. Post as the ablest person to prepare a book setting forth,

"What Does the Single Tax Mean", and we approve the book he has written

under that title for the Vanguard Press, and that this resolution of

approval be stated in a form acceptable to the Publishers.

7. Mr. Hennessy brought up the subject of a reasonable compensation to be paid to Mr. Louis F. Post for his editorial work in the preparation of this book, that Mr. Post had undertaken this work at the specific request of the Executive Committee, and had completed the same at great labor and had declined to receive any compensation other than reimbursement for stenographic bills paid out by him, that Mr. Post had returned a check for \$100.00 which had been sent to him on account of his editorial services; that such aervices were professional in character, for which compensation should be made. Mr. Brown also spoke on this subject as well as other members, and it was the unanimous feeling of all present that Mr. Post should accept a reasonable compensation for his services.

Upon motion by Mr. Brown and seconded by Mr. Hennessy, and earried unanimously, it was

RESOLVED, that the sum of \$500.00 be appropriated and paid to Mr. Louis F. Post in compensation for his editorial work in preparing the book "What Does the Single Tax Mean", and that the Executive Committee be instructed to transmit this sum to Mr. Post.

9. Upon motion made by Mr. Purdy, seconded by Mr. Brown, and unanimously carried, it was

RESOLVED, that the acts of the Executive Committee in the interim between the meetings of this Board to date be approved as the acts of this board.

9. Mr. Pleydell brought up the question of keeping in print the works of Henry George, and read part of a letter received from Hannibal, Missouri, addressed to Land and Freedom.

Upon motion made by Mr. Brown, seconded by Mr. Murphy, and unanimously carried, it was,

RESOLVED, that the Executive Committee be authorized in its discretion to make arrangements to keep all of the works of Henry

George in print so far as possible within the financial limitations of the Foundation.

- 10. Mr. Polak spoke upon the subject of creating a demand for the books of Henry George by means of essay contests in schools, by publication of news articles, in local papers, calling attention to the works of Henry George on the shelves of libraries and by other similar means.

  Mr. Polak was requested to present his suggestions in concrete written form to the Executive Committee.
- 11. It was the desire of the majority of the members present that the next stated meeting which will be held Tuesday, February 8, 1927, be held in the evening.
- 12. Upon motion made by Mr. Brown, seconded and unanimously carried, it was voted that the thanks of the Foundation be extended to Mr. Root, for arranging today's meeting at the Engineers' Club.

There being no further business, the meeting thereupon adjourned.

Dear Madam:-

Rev. Lisenby has just advised with me regarding your contract with Mr. O.K. Cummings, for purcahse of a leasehold interest under our Colony, in lots 4 and 5, blk. 28, div. 2, of our land.

Regarding same, I would say that this contract is lo looked upon by us as not in harmony with the purposes of our Colony, and in my opinion would not be approved by our Executive Council and according to clause 11 of our form of lease, as signed by Mr. Cummings, "leases are assignable only to members of the Corporation analyte or to persons acceptable to it" and that "assignments must be filed in the office of the Corporation."

In order to further protect the Corporation against action by lessees contrary to the principle of our organization we nearly a year ago amended our form of application for land adopting the longer form of which I am sending you copy, in lieu of the shorter form also enclosed. We have on file with his lease Mr. Cummings application on shorter form. You will note that this says: "I have read your constitution and pledge myself that while I hold lease of Fairhope land I will not oppose the full application of the principles set forth therein and contracted in your leases." To charge any one more than the value of improvements thereon for transfer of a lease, is certainly contrary to the principle of the constitution and lease and ma a transfer under such conditions will not be knowingly approved by the Corporation.

Mr. Cummings being unable therefore to make you an effective assignment of his lease it is my opinion that you have a right of action against him for the recovery of the amount you have paid and release from the contract to pay him additional payments.

I regret any annoyance caused you, appreciating that you were presumably an entirely "innocent party" but our Corporation is here demonstrating a policy which appears very vital to it and must not be expected to permit the flouting of the same.

In regard to the matter of a position in connection with the public school, it does not appear likely asked that there will be such an opportunity at Fairhope in the near as our scool now has a superintendent, who is in just that situation and who is very satisfactory. He was superitendent of a high school in Dallas, Texas, for many years, though having a farm home here where his family was, and as our own school reached a stage where it needed a superintendent and was justified in paying a salary which would justify some one in taking the place, he was persuaded to accept it, though the salary was a good deal less than he was getting in Texas.

There is a great demand for competent men however, in the growing communities of our County, and I would suggest that you get in touch b with our County Superintendent, S.M. Tharp, at Bay dinette, the county seat, as to the probability of there being an opening.

I am taking pleasure in sending you a folder regarding our Colon; one of the Chamber of Comperce of Fairhope and also a copy of Alabama Coastal News, which has a lot of general information about conditions in this county.
