His Untimely Death by Being Accidentally Shot

E.P. Duval, of the real estate firm of L.H. Green & Co. while making his evening trip home from Alosta last Saturday afternoon was killed by the accidental discharge of a gun hae was carrying in the buggy, the particulars of which may be gleaned from the annexed coroner's jury. Mr. Duval was a young man 22 years of age and formerly lived in New York. For a few weeks during the winter he acted as clerk of the Grand View Hotel, but later became one of the firm of L.H. Green & Co. he was a young man of brilliant attainments and highly respected by those who knew him. Services were held in the parlor of the Grand View Sunday morning, by Rev. Shelling. The body was taken to LosAngeles by L.H. Green, embalmed, placed in a casket and went to his mother's home in New York, in care of Orr & Sutch, undertakers.

## Coroner's Inquest

Coroner's Inquest, held this 30<sup>th</sup> day of April A.D. 1887, by John Shelton, Justice of the Peace, Acting Coroner and Dr. S. McCurdy, physician at Azusa, Los Angles county, California on the body of E.P. Duval:

Ramon Romano sworn, says: I live in Azusa; am a farmer.

- Q. What do you know about their case?
- A. I was burning near the road.
- O. What road?
- A. The old Azusa road?
- O. How far is that from the town of Azusa?
- A. In the town. I saw a team of gray horses pass, and a man driving; the man was in the buggy. I noticed he had a gun against his left side. After he passed me some eighy yards I heard the buggy strike a rock and heard the report of a gun. I turned round towards th ebuggy and I saw the man jump right up and fall upon the ground; saw the horses and buggy run up the road, then I ran towards where the man fell, and I thought he might be wounded and perhaps I might assist him. When I got to him he was lying on his back and I thought he was dead. Then I went up to the town and told Charley Wallen, and some other men came back to see him. When I got there Mr. Ramon Lopez was coming back with the buggy which had run away. Then Charley Wallen got in the buggy and went after the Justice of the Peace. I then went back to my work

John Shelton, Justice of the Peace, acting Coroner.

Jose Lopwz sworn, says. My name id Jose Lopez. I live in Azusa; am a laborer. I saw only the deceased pass in front of where I was at work with a shot gun in the buggy. The gun was on the left side. Shortly after he passed we heard the report and saw him fall. The horses had run away we heard the report of a gun. I also came over and found the man who was in the buggy dead.

Dr. S. McCurdy sworn says: My name is S. McCurdy. I live in Azusa. Profession, Physician and Surgeon. I do not know the deceased. I examined the body after the evening train came in. He was lying on his back dead on the ground. His body was still warm. Rigor mortis had not set in; think he had been dead for two hours. I found a wound on his left breast near the nipple. I think it was sufficient to cause his death. His coat was buttoned up and the contents of the gun having passed through his coat, vest and two shirts. That is all I know about the case.

E. L. Buck sworn says: I live in Monrovia; am in the real estate business. I know E.P.Duval. I saw him today, about 6 o'clock this evening; he was then dead. The body that I have just seen examined is the body of E.P. Duval. He lived in Monrovia. E.L. Buck

Articles found on the body: Letters to E.P. Duval, one cotton handkerchief, one purse containing receipts, memorandums, four lottery tickets, cigarettes, \$175 in bills, one watch, one chain, two corkscrews, bunch of keys, pencil, \$40 in gold &4 in silver, one shot gun with both shells empty, one day book, ledger and sketch book, maps, five shells loaded, one knife, one pair of gloves.

### A GREAT NUISANCE

Probably the biggest humbug and nuisance in Monrovia is the public telephone. It is not even a good thing to swear at, because it won't "answer back". We have watched the vain attempts of the operator in the central office here in sending a message, and have be come weary in waiting and had to go home. An hour is frequently spent in spending a simple message. Complaints are loud and long over the nuisance, but the superintendent doesn't seem to care a rap whether a new pair of lungs are worn out every mouth or not. One day this week twenty messages had to be refused. There were not enough hours in the day in which to send them. The result is that our people have to go to the depot and send their message by telegraph. There is talk of a branch office being started up town. In this event the telephone business will die out, because it is just as cheap to telegraph. If the telephone could be properly worked, a business of \$100 a month could shortly be built up. But this will no doubt go to the new telegraph office.

## **SEWAGE**

The Monrovia Land and Water Company have announced the purchase of seven hundred acres of land in the wash. Three miles down the valley from the town. The next sted will be to secure ways and means for the purchase and laying of a main pipe from the mountain to this wash. It is thought that an 8-inch pipe would be large enough for a town of fifteen thousand inhabitants. It is suggested that a tax be leveled on the property to day the cost of laying the main pipe. It is to be hoped that the matter will not be delayed.
