THE WATER QUESTION

Considerable fun was anticipated last Saturday at San Gabriel canyon, but everything passed off without ant fracas. The trouble arose out of the fact that the stockholders in the Duarte Mutual Irrigation and Canal Co. considered that a man named Phillips of Covina was appropriating water which did not belong to him, but which, rightly belonged to the company. Two-thirds of the water, which comes down the San Gabriel River, belongs to Azusa and one-third to Duarte, which gives both settlements a liberal supply. No other person or organization has the right to appropriate said water. The laws of California are, however, that no water shall be allowed to go to waste. Phillips, about two years ago, built a ditch to connect with the main Duarte and Azusa ditch, and took all the surplus water and run it into his own land. This did not prove to be enough to satisfy him, so he went to work to develop more. Near the mouth of the canyon and near where the owners got their supply, the river takes a turn around the corner of a steep bluff. Phillips cut a tunnel through this mountain and connected the tunnel to his ditch. The upper end of the tunnel came out a few feet below the bed of the river and of course there was considerable seepage from the river bottom into this tunnel and Phillips claims said water. This is what he calls "developing" water. Other people call it by a very different name - even stealing. Phillips also had a dam made below the entrance to his tunnel and set two men in a position to guard his interests. The people of Duarte and Azusa got tired of this sort of thing, and on Saturday last, as above stated, they made up their minds to have their rights or there would be trouble in the camp. Early in the day men began to arrive from all directions ready and willing to stand up for their own. The order was given to remove Phillips' dam and construct a new one, which would completely cut off the mouth of the usurper's tunnel. Sandbags were made up into a dam and the water turned in another direction. Phillip's zanjero was present at the time and called upon the men to detest, but they laughed at him. In a short time a flume is to be made and everything put into shipshape. When the work was completed Saturday, the Duarte and Azusa companies left two men to watch their interests, and should an effort be made to put the stream as it was formerly there will be some tall fun. No doubt a lawsuit will be the result, which will end in the squelching of Phillips.

ANOTHER NEW RAILROAD

An Electric Road from Los Angeles to Monrovia Now Let the Boom Commence in Earnest

A citizen's committee was held in the office of W.E. Pile and Company Friday afternoon. The object was to receive a proposition to build an electric railway from Los Angles, through Alhambra to Monrovia.

General W.A. Pile was appointed to the chair and was asked to make a brief statement of the proposition. He said that a number of gentlemen, who were largely interested in property in Alhambra and neighborhood, had formed a company for the purpose of constructing a railway from the city to that place. Their stock had all been subscribed and the completion of the road was an assured fact. The desire was to have the road extended to Monrovia, six miles further. It would cost in the neighborhood of \$5,000 per mile, or \$30,000 in all. Would the people at the end of the road put up their share of the money? The company is to build a roadbed and place thereon ties and rails - make a standard roadbed. A company of gentlemen who have the right to operate the Fisher system of electric railways in California, propose to lay down a third rail in the center, put on the rolling stock and place the road in through running order. When the road should be successfully operated for six months, the Railway Company shall pay them one-third of the cost of the plant; the second third in one year and the balance in eighteen months. If everything is not satisfactory they agree to forfeit a certain sum of money. The distance to Los Angeles would be fifteen miles, in almost a direct line. This distance could be covered easily in 30 minutes. The great benefit, which such a road would be to Monrovia, cannot be fully estimated in a moment. One must take time to think of the hundred and one ways in which our best interests would be served. The price of property would be greatly enhanced. The railway would cross the one from Pasadena to Long Beach near Alhambra or Ramona, came up through the lower end of Balwin's orchard, touch Arcadia and terminate in Monrovia. It would absorb the dummy road from Arcadia to Monrovia. A stock subscription list was started and upward of \$27,000 immediately subscribed. There will be no difficulty in obtaining the balance necessary.

The Railway Company meets in Los Angeles today to organize, and the stockholders here will become part of the company.

Reader, this railway is an assured fact. Depend upon it. Our citizens are alive to the best interests of this section, and they know that this is the best thing that has been brought forward. Now let us boom.
