#### THE CANNERY

For some time a project has been before the businessmen of Monrovia looking to the location of a cannery in this city. As we have before stated two gentlemen from Illinois have decided to locate in the valley in that business, either here or at Glendora, and the town will secure the cannery which offers the greatest inducement, other things being equal.

A meeting was held last Friday night to take steps in the matter, and after listening to a statement by Dr. Stevenson, who is acting for the gentleman, of what the institution would be and what was required from the citizens of the town where it is located, committees were appointed to wait upon some of the non-resident owners of property and to solicit subscriptions from the business men and orchardist of this vicinity. A considerable enthusiasm was manifested by those present and the meeting was adjourned until the following Tuesday night.

The second meeting was held Tuesday night at Barnes' hall, with G.W. Frazer in the chair. After the reading and approval of the minutes of the previous meeting, Dr. Stevenson was called upon and outlined the proposed work of the cannery. It will cost, exclusive of the land upon which it is located, from \$8,000 to \$10,000 and will be sufficiently large to care for all the fruit grown between Lamanada Park and Glendora. It will also put up a large amount of vegetables, and will include all the branches of the business, such as making marmalades, crystallizing, evaporating, etc. No definite sum is required to be donated, but as the cannery must necessarily be run at a loss the first two years, the gentlemen interested feel that some support should be given them, the more especially as it will be a source of benefit to the town and surrounding country from the start. From \$300 to \$500 per day will be expended for labor and fruit during the season of seven months and that amount of money circulated here means much in the line of business and progress. By affording a market for fruits it will also encourage a better care of orchards, to secure the best possible fruits and stimulate the planting of other orchards. In short, it is a long step forward in the right direction.

A general discussion was indulged in by those present and the matter was viewed in every possible light. It was the unanimous conclusion that Monrovia could not afford not to secure the cannery – its necessity was apparent to all. Some partial reports were made by the committees and the subscription paper was circulated among those present with the result that a very handsome sum was contributed. Other subscriptions in land and money have been made and L.L. Bradbury, J.D. Bicknell, E.F. Spence and others have expressed a willingness to assist. The total promises to be quite enough to secure the prize.

We would say that it is thoroughly important that Monrovia secure this institution and that we have an earnest rival in Glendora. The public there has made an attractive offer, and Monrovia must not be backward or she may be outdone. Every businessman, every property owner and every laborer will be benefited and this institution will lead in locating others here. By all means let all who are interested attend the meeting at 7 o'clock Saturday night, when a final answer will be made by Monrovia. Don't forget it and don't fail to attend.

#### CITY COUNCIL

The regular meeting of the city council on Thursday night was attended by Messrs. Pile, Baxter and Banning.

The committee on streets and sewers was instructed to make contracts for guttering streets, to be ratified by the board.

The claims of Baxter, Brown and Henrickson were referred.

A letter from F.Q. Story, auditor of the Rapid transit road, was read and a motion prevailed that the marshal be instructed not to collect a license from said road until further action is taken by the board.

The deputy marshal was instructed not to take steps to collect delinquent city taxes and the attorney was ordered to report an ordinance extending the time when taxes shall be delinquent until the first Monday in January.

The city attorney was instructed to prepare an ordinance in reference to a right-of-way of a public highway across the cemetery.

The president and clerk were authorized to pay a note of \$1,000 due the First national bank out of the money collected for taxes.

The city attorney was instructed to frame an ordinance allowing persons to work out the road poll tax.

#### **NEW RAILWAY**

The Los Angeles, Utah and Atlantic railway company has filed articles of incorporation with the county clerk. The purpose is to construct a road from the Bay of San Pedro to Los Angeles and north through Kern, Inyo and San Bernardino counties to the east line of the state. There will also be a branch to Alamitos Bay. The directors are J.M.C. Marble, of Ohio, who is backed by twenty million dollars S.O. Houghton, L.R. Williams, L.F. Scott and C.W. Scott. This line will cross the Sierra Madre Mountains by the most practicable route, but what route that will be it is impossible to say. It may be the San Gabriel canyon. The road will be very important, as it will be the shortest through line to the east.
