WATER WAR

Another move was made in the Azusa water war Wednesday. The defendants, the Azusa Irrigation Company, by their attorneys gave notice to the plaintiffs, the Azusa Water Development and Irrigation Company, that on November 25th at 10 o'clock before Judge Hutton that the court make its order that such defendants and their attorneys be allowed and permitted to examine and inspect the development tunnel of the said plaintiffs, and to procure such tunnel to be examined by competent engineers of the defendants selection. This motion will be made upon the grounds that the plaintiffs refused to permit such inspections and examinations of such tunnel should be had at this time by the defendants.

This notice is accompanied by the affidavit of John Scott, one of the defendants, who deposes and says that the defendants claim that by running a tunnel under the bed of the San Gabriel river it has developed a certain amount and flow of water and above and independent of what flows in the river on the surface and that such flow does not decrease the supply of water to which the defendants are entitled or accustomed to divert into their ditches or flumes. The defendants claim that the water flowing from plaintiff's tunnel under said San Gabriel River does diminish the supply to which they are accustomed and entitled to divert from said river. That work on said tunnel has been for some time nearly or quite suspended, and at the present time it can be seen at what part and from what source the water comes into the same. That plaintiff's are now clearing out and repairing such tunnel, and are about to timber the same, and when this is done it cannot be determined so well from what source and direction the waters enter said tunnel. nor can an examination be so well made after high water in the river. That it is necessary for defendants to have a survey and an examination of said tunnel in order to properly to prepare their answers for the trail. That an injunction has been issued in this action against the defendants herein. That the defendants desire to inspect said tunnel, but the plaintiffs refused and still refuse them permission to enter the same unless by force. Judge Hutton entered an order in accordance with the above, and the motion will be argued at the time stated.
