Agreement made to protect depot

Fearful that the historic Monrovia train depot could be demolished, the City Council has signed a protective license agreement with the Atchison. Topeka & Santa Fe Railroad Company.

Terms of the agreement protect the depot from demolition and place the city in the best position to eventually purchase the old station. In return, the city will pay an annual \$360 license fee and has placed a security fence around the depot to minimize vandalism and railroad liability.

With the contract, the city also hopes to cut its property acquisition time by about 50 percent, said Glenn Cox, redevelopment division manager.

"It normally takes a long time to purchase property from the railroad," he said.

"It's long been the city's position to do everything possible to refurbish the building and put it to use. Yet that is an expensive course of action," Cox said in a report.

It could cost more than half a million dollars to acquire the depot's approximately 1.5 acres, Cox estimated. The city's goal, he added, is to purchase the property and sell it to a developer willing to restore the site.

The depot was built in 1928 when passenger trains made frequent stops in the foothill community. As freight trains began dominating the rails, the now while the city decides what

depot closed and local presevationists have kept an eye on it ever since.

The Monrovia Chamber of Commerce and other local groups have been interested in restoring the site, said Jan Marugg, executive vice president of the chamber.

"Progress is kind of in limbo

to do," she said.

In a related issue, the chamber has supported a proposed county commuter rail connecting Los Angeles and San Bernardino. The light rail would use existing depots at Pasadena, Los Angeles, San Bernardino and Monrovia, according to Stephen Lantz, community relations manager for the Los Angeles

County Transportation Commis-

The county commission is currently drumming up local interest in the light rail and has yet to acquire the right of way from the railroad. As many as 11 stations could service the commuter system, including seven new facilities and the four existing depots.
