GRANT OF RASEMENT

CONSOLIDATED ENGINEERING CORPORATION, a corporation, organized under the laws of the State of California, and having its principal place of business at 300 North Sierra Madre Villa, Pasadena, California, hereby grants to SOUTHERN CALIFORNIA EDISON COMPANY, a corporation, its successors and assigns, the revocable right to construct, use, maintain, alter, add to, repair, replace, and/or remove, in, on and over the real property hereinafter described, situated in the County of Los Angeles, State of California, an electric line, consisting of poles, necessary guys and anchors, cross-arms, wires and other fixtures and appliances, for conveying electric energy to be used for light, heat, power, telephone and/or other purposes.

Said real property is described as follows:

The Southerly 6 feet of that portion of Lot 3 in Section 36, Township 1 North, Range 11 West of the Subdivision of the Rancho Azusa de Duarte; as per map recorded in Book 6, Pages 80 to 82 inclusive, of Maps, records of said County of Los Angeles, which portion is described as Parcel #2 in the deed to the Grantor herein recorded April 1, 1952, in Book 38602, Page 443, of Official Records, records of said County.

The Grantee, its successors and assigns, and its and their respective agents and employees, shall have the right to trim or top such trees as may endanger or interfere with said electric line, and shall have free access to said electric line and every part thereof, at all times, for the purpose of exercising the rights herein granted.

The easement herein granted and all rights acquired by the Grantee hereunder shall be revocable upon sixty (60) days written notice given to the Grantee, its successors or assigns by the Grantor or its successors or assigns, and within sixty (60) days following receipt of such notice the Grantee, its successors and assigns shall be bound to remove said electrical lines and all poles, guys, anchors, cross arms, wires and other fixtures and appliances associated therewith.

The Grantee, its successors and assigns shall be bound, upon sixty (60) days prior written notice from the Grantor or its successors or assigns, to remove any poles, guys, anchors and other fixtures and appliances which interfere with any side track or railroad spur to be constructed on said property.
