PHOTOGRAPHIC COLLECTION USAGE

The Monrovia Historical Society is pleased to provide images from its collections for personal, business and scholarly use. Individuals using photographs for home decor, research, or other personal uses, and local historical organizations (MOHPG & Monrovia Historical Museum) need only pay a fee for any print reproductions; there is no fee for electronic images. Use of the photographs for commercial purposes -- such as decoration of business premises or a publication for sale-- requires a commercial use fee, which goes to sustain the collection.

COPYRIGHT

The Society holds the copyright on most of the images. However, some of the older photos are in the public domain. It is the responsibility of the user to follow copyright restrictions, if any.

CONDITIONS GOVERNING USE

Requests for use are governed by the following conditions:

- Images used in printed publications, on film and videos, on websites and in exhibitions are to be credited with the following: “Monrovia Historical Society”.
- Images will be provided at a resolution of 300 dpi unless otherwise requested.
- The requester using images for commercial purposes will give the Society a complimentary copy of the published work(s) in which the photographic reproduction appears.
- In authorizing publication of an image, the Monrovia Historical Society does not surrender its own right to publish it, or to grant others permission to do so.
- Granting permission to use of materials does not absolve requesters from securing permission from the copyright holder if the material is not in the public domain, nor does it affect the payment of additional fees as required by the copyright owner. Users assume all responsibility for questions of copyright, invasion of privacy and rights of publicity that may arise in using reproductions from the Library’s collections.
- The Society reserves the right to limit the number of reproductions; restrict the use of rare or fragile materials; and institute special fees for items requiring special handling.

NOTICE: WARNING CONCERNING COPYRIGHT RESTRICTIONS

The copyright law of the United States (Title 17, United States Code) governs the making of photocopies or other reproductions of copyrighted material.

Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or other reproduction.
