## 126 Poppy Avenue

John H. Bartle and Frank J. Cornes were pioneers of Monrovia, the former arriving in 1886 and the latter in 1894, the year that John Bartle became president of the First National Bank of Monrovia. Both men became friends and business partners. They purchased land located east of the original Monrovia Tract, and created the Fairmont Tract of 57 residential lots circa 1904. This was at a time that Monrovia's active growth had begun once again after the arrival of the Pacific Electric Railway in 1903. Will the newly arrived Gold Line Extension create an historical parallel?

The Dusenbery Brothers, Guy H. and Glenn C. were in Monrovia by1908. They operated a Billiards and Pool Hall at 618 S. Myrtle Avenue, where they also sold cigars and tobaccos. Guy Dusenbery and his wife, Ella, had left Monrovia for Inyo County by 1910, leaving Glenn as the sole proprietor of the business. Glenn and his wife, Bessie, had been renting, but by 1912 they were ready to build their first home. They purchased Lot 19 in the Fairmont Tract from H. J. Caldwell, and contracted with the Tifal Building Company for the erection of a two bedroom Craftsman bungalow. Building permit number 147 was issued by the City of Monrovia on March 15, 1912. \$2,300.00 was the stated value of the new construction. Glenn and Bessie, together with their daughter, Erma, move into their new home later that year.

The Glenn Dusenbery family also left Monrovia for Inyo County, and the house was sold to Edgar Slone and Ida Short Emmett, formerly of Ventura, California. They first appear in the Monrovia City Directory for 1919-1920. There were three daughters who lived in the house: Evelyn Grace, Rose Winifred, and Edna May Emmett. Edgar Emmett died from tuberculosis on February 16, 1920 at the age of 34. The Emmett family undoubtedly moved from Ventura to Monrovia for Edgar's health, since Monrovia had become a well-known center for the treatment of tuberculosis due to the work of Dr. Francis M. Pottenger and others.

Ida Emmett remained in the house with her daughters for the next fourteen years. She then returned to Ventura. By 1935, Ida Emmett had sold the house to Robert D. and Helen M. Mac Donald, natives of Minnesota. They were already residents of Monrovia, first appearing in the Monrovia City Directory for 1930. Robert MacDonald died November 29, 1938 at the age of 44, perhaps from injuries suffered as a U. S. Army volunteer during the First World War. Helen Mac Donald continued to live in the house as a widow with her son, Earl D. Mac Donald.

By February of 1947, Helen Mac Donald had sold the house to John A. and Mary E. Stanley, who had been living on an orange grove in Duarte. John Stanley died circa 1950, but Mary Stanley continued to live in the house as a widow. She was the resident when the last Monrovia City Directory was compiled in 1971. Later residents of the house were Tom and Beverly Burns, who added a third bedroom and second bath to the house in 1995. The present owner of the house purchased it in 1996, and is currently in the process of applying for local landmark designation.
