WESTON CEMETERY MARKER DEDICATION Champoeg State Park August 22, 1985

We are gathered here to remember one of the 100-plus early Oregon residents who took part in the historic provisional government's ground-laying on this very spot on May 2, 1843.

David Weston is the only one of those 1842 Oregon Trail pioneers in the first family migration in the Willamette Valley to be buried on land that is now within this oldest Oregon State Park.

Only the graves of eleven in the Weston family cemetery and that of Kitty Newell, wife of Robert Newell, whose land claim adjoined Weston's, are known to be within this historic park. Mes. Newell, daughter of a Nez Perce Indian chief and mother of five sons, died in January 1845, nearly 31 years before David Weston's life ended at 55 in December 1875. Kitty Newell was the sister of Mrs. Joseph L. (Virginia) Meek and of Mrs. Caleb Wilkins, who also were wives of "Mountain Men" participating in the 1843 voting here.

His burial plot is on the westernmost part of land on which David Weston settled in 1850 on his return from the Cayuse War. He was one of the volunteers from the valley who responded following the 1847 Whitman Massacre at Waillatpu. He took up his claim near his blacksmith shop in the town of Champoeg, a portion of land destroyed by the 1861 flood. It was to that claim that he took his Oregon-born bride, Mary Sinclair, in 1852, after their marriage in St. Paul Catholic Church.

Until this summer there had been no identification on the Weston Cemetery for several decades. A wooden fence which early bordered it had given way to the elements years ago.

David and Mary, who died in 1884, and five of their babies, along with three other infants, are buried in the family cemetery. It was used from 1855 until 1896. Last interment there was for David's brother, Alfred Thomas Weston, who came to Oregon in 1852 with another brother and two young half-sisters and a half-brother. David and Mary's oldest daughter, 18 at the time of her father's death, completed work to obtain title to the land claim. In 1968 her heirs deeded the half-acre to the State of Oregon to square up the eastern boundary of the then-expanding State Park. It is a wooded strip north of the intersection of Case and Champoeg (formerly Weston) Roads.

Weston grandchildren--all now of retirement age--have provided a gray granite marker for their grandparents, their uncle Tom, and the eight infants who were given interment on the family farm. No survivors, of course, ever knew any of the eleven.

Most 1843 voters' living descendants are in later generations, but the Westons for the most part were late in having families. Five of the twelve Weston grandchildren now living--four grandsons and one granddaughter--all Oregon-born--are children of David and Mary's youngest son, Lewis Sinclair Weston, who was not yet six years old when his father died in 1875 on his donation land claim.

Only four of David and Mary's eleven children attained adulthood. The youngest was born six months after her father's demise. She lived on the Weston farm and later in the Newell House, at attended school at Butteville. Her 85 years were lived in Oregon and Washington.

Mary, 32 great-great-grandchildren, and several sixth generation descendants complete the living family.

The family deeply appreciates the cooperation of Champoeg Park's personnel, particularly that of Max Ruff, manager, and Sallie Jacobsón, in permitting placement of the granite marker on the family cemetery. The plot is on high ground accessible only on foot through the park's nursery planting north of Champoeg Road and east of the eight-year-old Visitors' Center and Champoeg Creek bridge.

This evening we recognize the contribution made by all who participated in the 1843 meeting here, as we pay respect to the memory of the Indianaborn David Weston—one of ten from the small 1842 migration to take part in the historic 1843 meeting on this spot.

Our thanks to all of you for joining the family in this event. Please now enjoy the get-acquainted evening and picnic supper planned for you.

THE DAVID WESTON D.L.C.

DAVID WESTON settled his Marion County claim Nov. 15, 1850, according to Oregon State Archives records. Prior to Dec. 31, 1847, he had land in Yamhill County east of the Robert Ady's 640-acre claim on the Willamette River. Ady's claim also cornered those of Louis LaBonte and Michel LaFramboise. Weston answered the call for volunteers at time of the Whitman Massacre in November 1847 and in 1849 is listed as an American voter from Champoeg County.

LESS THAN three weeks after her father's death Dec. 19, 1875, the oldest child, Mary Jane Weston, 20, filed a \$2,000 bond in Marion County as administratrix of David's estate. Heirs were listed Jan. 5, 1876, as Mary Jane, James 18, and Lewis 5. (Inez was born six months later, June 6, 1876.) Appraised by William M. Case, J.B. Piette and Ed Mathiot, the land was valued at \$2000 and personal property at \$200. Affidavits for Mary Jane's certification request were signed by John S. Smith, James Henshaw, C.F. Ray and William M. Case. Patent on the 322.5 acres was filed in Marion County deeds book 62, page 65, June 14, 1877. Certificate 4747 recorded May 7, 1895, shows notification was No. 773 for claim 65 (sec. 6,7, T4S, R1W) and claim 44 (sec. 1, 12, T4S, R2W). This and the following data until Dec. 7, 1943, is in a document of that date on the final 95.12 acres in second-generation ownership, prepared by Union Abstract Co., 525 Court St., Salem, OR. The abstract came into family possession in the 1960s.

JAMES WESTON at 23 gave a quitclaim deed Feb. 8, 1881, on his interest in the land. On Nov. 1, 1882, the widow, Mary Weston Gay (married Dec. 5, 1878) and husband, Joseph Gay, along with James and his wife, Sophia, and Mary Jane Weston gave a quitclaim deed to William M. Case for the 322.5 acres. Mary Jane (married in 1886 to Adolph W. Jette) declared in 1887 that she had forfeited all rights and had no interest in the land.

LEWIS WESTON, at 21, for \$500 gave a warranty deed to A.W. Jette for his one-fourth interest in the property. On Dec. 13, 1893, he acknowledged satisfaction in full of a \$219 mortgage on his quarter-interest. That one-quarter was included in a quitclaim deed for the entire parcel given by A.W. and M.J. Jette to William M. Case. INEZ WESTON, 18, onJune 14, 1894, for \$500 gave Case a quitclaim deed for her interest.

THE WESTERLY part of the claim, No. 44, 95.12 acres, was returned to Mary Jane Jette Nov.9, 1895, for \$2,500 in a quitclaim deed from William M. and Eliza Case. The Jettes on Nov. 9, 1898, sold that acreage to William S. Flynn, ending Weston ownership of all acreage except the halfacre cemetery. On Feb. 23, 1904, Flynn sold that land, with Willamette riverfront, to Tung Lee for \$4,000. Tung and his wife, Sue Sam, lived in the old Weston house and operated a hop yard on the riverfront land. The Lees deeded the property to his sister, Ruth Bertha Lee, March 10, 1921, giving Flynn as easement to Weston's Landing for his own exclusive use in shipping his produce. On Jan. 5, 1937, Ruth Lee granted a strip of land involving 11.54 acres, for widening of Champoeg Memorial Highway in front of the Weston house. Marion County records show that the Lees paid taxes on the property through 1942-4. The Lees sold the 95.12 acres in 1943 to Leslie Eppers, Aurora farmer. The riverfront farm land later was sold and a strip along the river became part of Willamette Greenway, now the Champoeg Park-Butteville bicycle path which passes Dave Weston's landing.

EPPERS SOLD the 5.5-acre parcel on which the Weston house stood, east of the county road, to Donald D. Danner of Portland a few years later. Eppers had torn out the brick fire-place and was in process of razing the house. Danner sought to restore it as a hobby. In the fall of 1959 he sold the property to David Weston's grandson, William G. Weston, and wife, Myra. The house had weathered record Willamette River floods of 1890 and 1964 and war greatly deteriorated, and was torn down. After 24 years' ownership, the Westons sold the 5.5 acres intersected by Mill Creek to Theodore H. Roberts Jr., and Mary V. Roberts, whose mobile home is now on the land at 9408 Champoeg Road No.E., Aurora, Gregon.

THE WESTON CEMETERY on the western edge of the D.L.C. was deeded to the State Dept. of Transportation for park purposes in 1968 by heirs of Mary Jane and A.W. Jette. The naturally wooded half-acre on high ground was included in Champoeg State Park to "aquare up" its eastern boundary and is not slated for park development. A granite marker was placed by third generation descendants on the cemetery plot in June 1985 as a memorial.

Godfather William Gladman, who has signed with us, godmother, Genevieve Longtain who could not sign. (Munnick, Catholic Church Records of the Northwest..) Catherine died Dec. 10, 1854, at the age of 20 months, and was buried in the St. Paul mission (old) cemetery Dec. 11. She was given by F.N. Blanchet, archbishop of Oregon City, as "legitimate daughter of David Weston, blacksmith, and of Mary Sinclair," and witnesses as Louis LaBonte and David Weston.

married ADOLPH W. JETTE Feb. 2, 1886. Two daughters. She died at Moclips, Wash. May 19, 1932, at the age of 77. Adolph Jette, son of Adolphe and Julie Jette, died 1932; born Aug. 4, 1863; baptized as Adolphe Gilbert Jette, 16 August 1863 by J.F. Malo, priest.

ELLEN WESTON (Barkefer) - Kansas City, Mo., last known came to Oregon 1852; returned to Missouri 1857; died 1916.

On Dec. 15, 1852, he and brother, Thomas, signed a petition in opposition to a road through T. D. Keizer's farm, and was then living in Marion County. (according to State Archives records)

ALFRED THOMAS WESTON (ninth child and seventh son of William Jasper I and Nellie)
born April 16, 1833

to Oregon in 1852; returned in 1868 to Kansas, where he was married in Leavenworth in 1870 to Inez Gruelle; daughter, Jane (last known to be living in St. Helens, Ore.) Tom returned to Oregon, separated from wife.

He lived near Sherwood, where he died in 1896, and is buried in the David Weston cemetery at Champoeg. (Widow married a _____Todd and lived at St. Helens)

LEWIS WESTON (eighth child and sixth son of William Jasper and Nellie Lewis Weston) born Sept. 15, 1831 to California (1852 ?) married in Mariposa County, Calif.; homesteaded on Sherlock's Creek near there. 9 & children: (not in order) JANE (married a James) lived at Coquille, deceased ADDIE (married Bell) had children; was living in Merced, CA., Apr 1892 ALICE M. (married Judkins), last known in Richmond, CA. (youngest child) ANNIE L. (latest information to Lewis S. Weston, cousin, Sept16, 1892) GEORGE CHARLES H. (next to youngest sonliving in Atwater, CA. 1893) WILLIAM JASPER III JOHN ELLEN (married Halterman)

When ANNIE L. WESTON wrote Sept. 16, 1892, to cousin, Lewis S. Weston in Champoeg, she noted that Mariposa had five stores, three saloons, two hotels, two churches and "many" residences.

ALICE M. WESTON wrate June 2, 1892 (as a schoolgirl, as was Annie) that they were living on the homestead six miles north of Mariposa, on Sherlock's Creek. Mariposa was a mining community. Three of the girls were married: Hak Halterman, Bell and James being given as names of brothers-in-law) Addie and "children" had been "up from Merced" and Charles H. was living in Atwater. They had cousins, Hattie, Will and Edith (Smith) living in Portland; children of Margaret Ann Weston and Capt. William H. Smith.

ALICE wrate Oct. 24, 1892, to say that that ADDIE BELL's house had burned, her baby saved. The house also was home to ELLEN, and CHARLES AND GEORGE were visiting there, all losing all in the fire. Alice inquired! "How is Uncle Tom?"

MARGARET ANN WESTON (second daughter of William Jasper I and JANE Montgomery Weston born May 16, 1840 in Arkansas; died in Portland Oregon Feb 7, 1922 to Oregon 1852 with younger brother, William Jasper II, 7, sister Rachel, 14, and two half-brothers, James and Alfred Thomas Weston.

married William H. Smith, pioneer steamboat captain, born June 16, 1831, in London England; died at 81 in 1912 at Portland.

married June 12, 1854 (she was 14) at Oregon City.

Smith came to Oregon Jan. 1, 1853, settled on Yamhill County claim March 28, 1855, filed for U.S. citizenship, which was granted July 13, 1859, Aaron E. Wait, circuit judge, Portland. Clipping of his obituary in 1912 indicates he left his widow, nine children, 17 grandchildren. - They had 12 children; nine survived him. When Capt. Smith sold his Yamhill County claim March 15, 1864, to William Kiernan, affidavits were signed by David and Thomas Weston and Martin James. (State archives)

WILLIAM JASPER WESTON II, youngest son of William Jasper I and Jane Weston, born Aug. 28, 1845 near Little Rock, Ark., only son of this marriage. Both parents died in 1845. He came to Oregon in 1852 with his two half-brothers, James 28, and Alfred Thomas (Tom) 21, an his sisters, Rachel 14, and Margaret Ann 12. He probably had his seventh birthday on the Oregon Trail, and had never his oldest halfbrother, David, a pioneer of 1842, until his arrival in the Willamette Valley.

Married SARAH BEAVERT, 14, in 1873; he was 28 years old. They lived out their lives on their farm at Pleasant Hill in Clackamas County, near Sherwood, OR. of their 10 children they are buried in Pleasant Hill Cemetery. William Jasper II died in 1922; Sarah in 1916.
