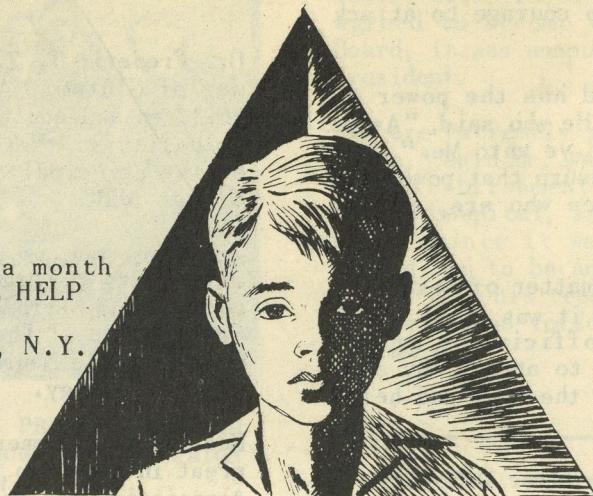

LATE BULLETIN:

SPEECH CLINIC ENDOWED! LENA INVALID AID SOCIETY TO SPONSOR.

As this issue of OUR CHILDREN'S VOICE was ready to go to press, announcement was made by AHRC President Nathan Feder that the Lena Invalid Aid Society, Manhattan philanthropic group, had agreed to donate \$6,000 a year for the establishment of a speech clinic for mentally retarded children.

The importance of speech therapy for mentally handicapped children has long been recognized. One authority in this field recently stated "We have noticed that speech therapy gives the child more than just language and speech. In training for speech, we train higher centers of learning, and thereby stimulate the child in multiple areas."

While detailed information is not yet available, it is understood that the speech clinic may possibly be

PLANNING PROCEEDS FOR BROOKLYN CLINIC. GRANT EXTENDED TO THREE YEARS

Plans for the establishment of the Brooklyn clinic for retarded children are rapidly taking shape, according to an AHRC spokesman. Negotiations are under way for affiliation with a hospital in that borough, and a detailed announcement is expected in the near future.

It was also announced that the Ladies' Auxiliary of the Morris J. Solomon Sunshine Fund, sponsors of the clinic, have extended their grant to a three year period. This action, it was pointed out, will permit planning on a basis of permanence which will enhance immeasurably the broadness and comprehensiveness of the entire program.

WHY WE FIGHT

(An Editorial)

On April 6th, State Senator Mario M. DeOptatis of Brooklyn delivered a wantonly cruel attack upon our children.

On that date, the Brooklyn Eagle published a full-column article concerning a letter written by Senator DeOptatis to Governor Dewey. His letter had to do with the question of extending the lease of Halloran Hospital, rather than turning back the facilities to the Willowbrook State School for Mentally Retarded Children. (See story on P. 4)

In voicing his opposition to the latter, the Senator — as quoted by the Brooklyn Eagle — characterized mentally retarded children in these cynically inhuman words: "CHILDREN WHO ARE PHYSICALLY AND MENTALLY DEAD".

"PHYSICALLY AND MENTALLY DEAD"...These are the little ones whom some of the ambulatory wounded veterans at Halloran — for whom Senator DeOptatis professed to speak — have visited on the adjoining grounds at Willowbrook; for whom they have bought toys and candy; whom they have loved and taken to their hearts. For they have recognized these children as being as grievously wounded as they are themselves. Instead of an enemy bullet, it has been a cruel accident of nature which has hurt them; but they are equally alive, equally in need of sympathetic understanding and love. These veterans, we are sure, would be the first to reject the Senator's arrogant condemning of these children — in their name — to the scrap-heap.

Many of these men fought in Europe. They fought against an enemy whose pagan philosophy included consigning to the furnace-flame the physically and mentally handicapped, as being of no use to their master-state. Does Senator DeOptatis consider these

children similarly expendable? For of course, they can cast no votes. It requires no courage to attack them.

Most of us believe that only God has the power to confer life or take it away. Only He who said, "As ye do unto the least of these, so do ye unto Me." Does Senator DeOptatis stand ready to usurp that power; to proclaim "dead" these little ones who are, politically, "the least of these"?

The issue is far larger than the matter of returning Halloran to the children for whom it was built. It is a question of whether a public official — or any individual — has the moral right to attack, by such viciously false characterization, the weak and helpless.

Possibly this Association owes Senator DeOptatis a vote of thanks. For unwittingly, he has pointed up to us a vital function — perhaps the "reason for being" — of this organization. He has made crystal clear to us why we can never afford to relax our efforts; whether it be that of an individual member to sell one more raffle-ticket, or an attempt by the Association to launch some huge project.

Some day, it may be, we will have achieved all the physical facilities — the schools, clinics, sheltered workshops, institutions, and all the rest — that our children so desperately need.

But always, the need will exist for organized vigilance against those who would, for selfish reasons, traduce and betray "the least of these."

established as an adjunct to the Flower-Fifth Avenue Hospital clinic recently opened.

"Another big step forward" said Mr. Feder, "has been taken by the AHRC in its program for total training of the mentally retarded child. And once more, that step has been made possible by a great-hearted group of women whose humanitarian spirit is matched by their enlightened approach to a problem so little understood by society through the ages. I wish I could adequately express to Mrs. Lillian Segall, President of the Lena Invalid Aid Society, and to all that wonderful group, how deeply grateful we are. So long as there are women and groups like theirs, we need never feel that we are fighting alone. By taking our children — and our cause — to their hearts, they have given us renewed hope and determination."

DR. ZIMMERMAN, GLUTAMIC ACID PIONEER, TO ADDRESS NEXT PUBLIC MEETING OF AHRC ON MAY 5TH

Dr. Frederic T. Zimmerman, who has pioneered in the use of Glutamic Acid therapy on mentally retarded children and adolescents, and who is a distinguished authority in the field of mental retardation, will be the principal speaker at the next public meeting of the AHRC.

Dr. Zimmerman is research associate at the Columbia University College of Physicians and Surgeons, Department of Neurology. He is also assistant attending neurologist of the Neurological Institute's Department of Child Neurology, and a Diplomate in neurology and psychology.

Because Dr. Zimmerman's views are expected to be of great interest to both parents and professionals, the Association has reserved the auditorium of Stuyvesant High School in anticipation of a large attendance.

The meeting will be held Friday evening, May 5th, at 8 P.M.

Stuyvesant High School is located on 15th Street, between First and Second Avenues, in Manhattan.

These meetings have had a two-fold purpose: to bring into more intimate contact the AHRC members with their borough-neighbors; and to intensify the efforts being made in connection with the forthcoming First Annual Dinner of the Association on May 20th.

Speakers at the meetings included AHRC President Nat Feder, Executive Director Joseph T. Weingold, and Fund-Raising Chairman Jack Max. Members were advised of plans for various projects which it is hoped will be effectuated in the near future, and urged to redouble their efforts in selling raffle-books and Journal-ads for the Dinner, so that funds needed for the continued functioning at maximum level of the AHRC could be raised.

Refreshments were served, and a number of prizes donated by members were raffled off, with proceeds going toward the respective boroughs' Dinner Fund.

The Bronx meeting, held April 11th, at the Rivoli Plaza, was under the direction of Bronx Coordinator Shirley Hujnick.

In Manhattan, Dora Banner, Coordinator for that borough, held a meeting on April 13th, at the West-over Hotel.

A meeting for Brooklyn members was arranged for Sunday evening, April 23rd, at the Tropic Isle, by Brooklyn Co-ordinator Rose Nussbaum.

All of the Borough-Coordinators expressed deep appreciation to their committee members for their tireless efforts in planning and preparing for these meetings.

DR. SLOBODY JOINS BOARD OF ADVISORS

Dr. Lawrence B. Slobody, Director of Pediatrics at Flower-Fifth Avenue Hospital, and Director of the recently established clinic for mentally retarded, has agreed to become a member of the AHRC's Advisory Board, it was announced by Nathan Feder, Association president.

"We are extremely gratified at Dr. Slobody's acceptance," said Mr. Feder. "The great part he played in the establishment of the clinic at Flower-Fifth Avenue Hospital, and his devoted efforts as its Director since it went into operation, have already proved him to be an invaluable friend of our cause. Add to this his recognized professional eminence, and we are indeed fortunate in having him as one of our Advisors."

BISHOP GILBERT BECOMES AHRC SPONSOR

The Rt. Rev. Charles K. Gilbert, S.T.D., Bishop of New York, Protestant Episcopal has agreed to join the Board of Sponsors of the AHRC, it was announced by Executive Director Joseph T. Weingold.

Bishop Gilbert thus joins the growing list of religious leaders of all faiths who are lending their support and encouragement to the Association's efforts on behalf of the mentally handicapped, "regardless of race, color, creed or age."

**BORO. PRES. CASHMORE
 PLEDGES AID TO AHRC**

On Monday April 3rd, Brooklyn Boro. Pres. John Cashmore met at his offices with AHRC President Nathan Feder, and Congresswoman Edna Kelly, who is an AHRC sponsor, to explore the methods by which he could actively participate in the Association's efforts. Also present was Deputy Commissioner Albert M. Leavitt, City Coordinator for the Association.

Mr. Feder, Congresswoman Kelly and Mr. Leavitt explained briefly the background and objectives of the AHRC, and the problems involved. President Cashmore expressed great sympathy and interest, and promised his vigorous support of any activities undertaken in Brooklyn. He immediately agreed to act as Honorary Chairman of the Brooklyn Sponsors' Committee. He also volunteered to call a special meeting in the near future, at his office, of prominent citizens in Brooklyn who could contribute materially to advancing the AHRC's program.

Further developments will be reported in future editions of OUR CHILDREN'S VOICE.

GOV. DEWEY WEIGHS NEEDS OF RETARDED. WILLOWBROOK PLANS UNDER CONSIDERATION.

Despite present plans to return Halloran Hospital to the State for the use of mentally retarded children, Governor Dewey may take action to maintain the facilities as a hospital for veterans, according to an article in the March 28th issue of the N.Y. Herald-Tribune.

Originally built as the Willowbrook State School for Mentally Retarded Children, the facilities were taken over by the War Department upon completion. Three-fifths of the facilities were leased to the Veterans Administration in 1947, with the understanding that it was to be for short-term occupancy.

Veterans' spokesmen have protested to Governor Dewey the June 30th termination of the lease. However, according to the Herald-Tribune, "State officials take the position that the V.A. has other facilities in this area, which can care for the patients now at Halloran; in particular the 1000-bed Fort Hamilton Hospital in Brooklyn." Dr. Frederick MacCurdy, until recently State Commissioner of Mental Hygiene, pointed out that the state has in its charge 20,000 mentally deficient children, crowded into six institutions.

The AHRC, together with other organizations concerned with mentally retarded children and child welfare in general, is voicing opposition to any delay in returning the facilities to Willowbrook. At the last general meeting of the Association, on March 28th, Executive Director Joseph T. Weingold urged all members to write or wire to Governor Dewey. He pointed out that, while other facilities are available to the veterans, and additional ones are under construction, no others exist at all for mentally retarded children, and none are in immediate prospect.

"The badly crowded institutions," he declared, "constitute a serious obstacle to the proper care and training of the children now occupying them; and act to deter many parents from applying for institutionalization of children now at home. In a great number of such cases circumstances are such that the health and welfare of both child and parents is seriously menaced as a result."

He concluded by saying that, while members of the AHRC — many of whom are veterans — are sympathetic to the needs of the veterans, a clear-cut issue of the greater need was involved in this instance.

Among other organizations which have voiced their opposition to extending the Halloran lease is the Welfare League for Retarded Children, composed of parents whose children are in Letchworth State School for the Mentally Retarded.

As we go to press, we learn that Governor Dewey has decided to permit the V.A. to continue using approximately half of the facilities it now occupies until December 31, 1952.

AHRC RECEIVES NATION-WIDE PUBLICITY

Mail Pours In From Entire Country

The widespread publicity which the AHRC has been receiving from a variety of sources, including articles in national magazines, has resulted in recent weeks in an amazing flood of mail, which has virtually swamped the Association's offices. A considerable portion of this has been inspired by an article in the April issue of "Better Homes and Gardens" entitled "Not Quite Bright" by Judith Crist. Miss Crist's article deals with the problems faced by parents of mentally handicapped children, and spotlights the work of parents' organizations in coping with them, with conspicuous mention of the AHRC. As a result, parents from almost every state have written to ask for aid in solving their individual problems, and for guidance in forming parent groups where none now exist. The Association is making every effort to answer all these letters as quickly as possible, and to provide such help and advice as it can.

A sampling of just two days' mail included letters from the following places: Terra Alta, W. Va.; Colton, Cal.; San Antonio, Texas; Salisbury, N.Y.; Milwaukee, Wis.; Morgantown, W. Va.; Youngstown, O.; Williamsville, N.Y.; So. Norwalk, Conn.; Salem, Oregon; Cleveland, Ohio; Elberon, N.J.

Many of the inquiries were from educational directors, university libraries, social welfare agencies, psychologists and other professional persons.

Mrs. Banner gave a resume of the grave problems faced by parents of mentally retarded children, and explained the AHRC's long-range program for the amelioration of these conditions. Her address was warmly received by the attending membership.

Afterwards, Mrs. Banner expressed her deep appreciation for the sympathetic understanding and cooperation of Miss Dolly Lyons, Executive-Secretary of the Council, at whose invitation she appeared before the meeting.

A MESSAGE FROM OUR PRESIDENT

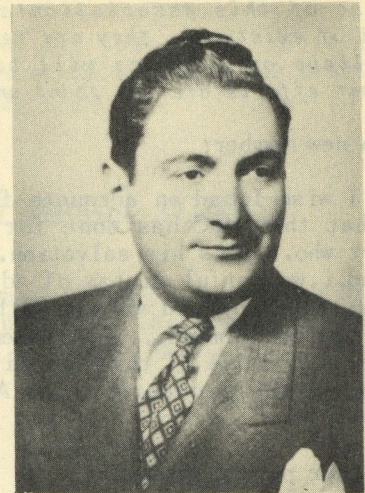

PROGRESS REPORTED IN SOCIAL ACTIVITY PROGRAM FOR ADOLESCENTS AND YOUNG ADULTS

A plan to provide social activity for teen-agers and young adults, which was described in the January issue of OUR CHILDREN'S VOICE, has made considerable progress since that time, according to Mrs. Eveline Leckart, AHRC member who presented the idea.

Mrs. Leckart states that she has succeeded in helping about a dozen youngsters to find companionship with one or more of the participants in the program. Activities have included home "get-togethers" and attendance at various forms of public entertainment. With the approach of summer, it is hoped to arrange beach parties and other outings on a group basis.

"For many of these boys and girls," said Mrs. Leckart; "this has been the first time in their entire lives that they have known what it is to have a friend; not to be lonesome and alone. I hope that this program will be expanded to include more and more of these young folk."

PUBLICITY COMMITTEE REPORTS PROGRESS IN RADIO FIELD

Increasing publicity for the AHRC is being obtained in the field of radio, according to Eugene Gramm, Chairman of the Publicity and Public Relations Committee. Mr. Woodhull Hay, who has been largely concerned with this medium, has been successful in inducing a number of radio stations to include station-break announcements regarding the AHRC in their daily programs. At present, stations WOR, WINS, WEVD, and WWRL are broadcasting such announcements, and others are expected to follow in the near future. The effectiveness of these station-breaks is attested to by the fact that, every day, telephone calls are received at the AHRC offices from parents who have learned of the be enrolled as members.

Mr. Hay is also in the process of communicating and conferring with radio-station officials with a view toward arranging personal interview programs in which an AHRC member would participate. In addition, he is hopeful of persuading some of the network officials to consider the presentation of "documentary" programs dealing with the problem of mental retardation.

Other activities in the field of radio included a recent appearance by Executive Director Joseph T. Weingold on the John J. Anthony program over station WMGM. Mr. Anthony interviewed Mr. Weingold on the problems faced by a parent of a mentally retarded child, and the efforts being made by the AHRC to improve the lot of the mentally handicapped. This interview produced a sizeable telephone and mail response, and the enrollment of a number of new members resulted.

Efforts are also under way to initiate television publicity in the near future, Mr. Gramm declared.

CARD PARTY HELD BY BROOKLYN MEMBERS

On Saturday evening, March 25th, a card party was held at the Brooklyn home of AHRC member Alice Pearlstein. Arranged as part of the campaign now being conducted by the Brooklyn Fund-Raising Committee, the gathering was attended by about fifty persons. Both as a fund-raising endeavor, and as a social function, the affair was described as highly successful by attending members.

CHAPTER REPORTS

WESTCHESTER CHAPTER

At the last meeting of the Westchester Chapter, it was voted to set up a cooperative day school for our children, using the facilities of the Pelham School for Children in Pelham Manor. Facilities there would be adequate for about 60 children at capacity. Initially, it is planned to establish small starting classes in three age-groups: nursery, school-age, and above-school-age. It is proposed to have two daytime sessions for each group, and we hope to start organizing these classes before the end of the year. A building-fund committee has been set up, with a kick-off meeting scheduled for April 18th at the White Plains YMCA.

A joint meeting of the Westchester Mental Hygiene Assn. and the Westchester Chapter of the AHRC will take place on Friday April 28th at the Rochambeau School in White Plains. This date falls within Westchester National Mental Health Week. Mr. Richard H. Hungerford will be the guest speaker; and Dr. Robt. E. Bell, superintendent of the first supervisory school district of northern Westchester, will also be present. New York members who are interested are invited to attend.

Plans are under way to start a school for retarded children in the northern Westchester area which, at the present time, has no special classes for such children. This will be a public school project, supported by the schools of the surrounding area and the northern Westchester Junior League. We are, at present, listing parents of retarded children who would be interested in having their children go to these special classes. Such parents are directed to Mrs. Emma Rosenberg, Croton 4622.

PUTNAM COUNTY

Mrs. Sylvia B. Mahar, AHRC member from Mahopac, N.Y., who is heading up the drive to form a chapter in Putnam County, reports that she hopes to have a sufficient number of members enrolled to formally organize this chapter in the near future. Her task has been complicated by the fact that communities in Putnam County are so widely scattered, and her own recent incapacitation due to an automobile accident.

Mrs. Mahar has also been active in attempting to bring about the establishment of CRMD classes in Putnam County. She reports that the prospects for the opening of such a class in September are now promising. This would be the first county-wide CRMD class in the state.

LONG ISLAND CHAPTER

The Long Island Chapter had its first Suffolk County meeting on March 20th in Bayshore, following the newly adopted policy of alternating the monthly meetings between Nassau and Suffolk Counties. Joseph T. Weingold, Executive Director of the AHRC, Board-Member Julian Banner, and Dr. Robt. F. Wagner, psychiatrist affiliated with Kings Park State Hospital, were speakers at the meeting.

Mr. Weingold gave a resume of the Association's origin and development. It was felt that his clear explanation of many questions raised, and his and Mr. Banner's presence, were of great helpfulness, and instrumental in the enrollment of a number of new members who attended.

Dr. Wagner's talk was one of the best we have had, and contained much valuable information regarding parental attitudes in dealing with retarded children.

The April meeting was held in Rockville Centre on the evening of the 17th. It was in the nature of a panel discussion, the principal participants being Margaret Reiss, Chairman; Emerson Dye, Chairman of the Educational Committee, and Christopher DeProspero, supervisor of the New York City CRMD classes. Mr. DeProspero is lending valuable service in an advisory capacity to our chapter. Gratifying progress is being made in increasing membership, and several very successful meetings have been arranged with Parent-Teacher Groups, Civic Clubs, and other community organizations.
