PRESIDENT'S LETTER

With this WHISTLESTOP we conclude another winter season at the Depot. After sixteen months of operation, we know two things:

First, the Cultural-Civic Center can operate on a sound financial basis with the small but important boost which our friends are giving the Depot through Life Memberships.

And second, the demand for meeting space reached every high level for which we had hoped. Already one thousand meetings have been held at the restored Depot.

What a tangible tribute to the entire concept!!

May I add, too, that this demand for space is the further reason to justify the support of the Life Membership drive which is now approaching a successful conclusion. As of May 1, more than \$80,000 had been pledged, with one or two Life Memberships arriving daily.

But it is vital that every dollar of the \$100,000 goal be pledged. The final \$20,000 will not come easily. In fact, it will only come if friends sit down after reading these words and mail in the pledge card now. (Or phone 262-1776 if you have no card.)

These Life Memberships are different and incorporate a new idea. The money will be assigned to a permanent endowment fund with only the interest to be used for operating. This interest will close the gap between rentals and store profits and cost of operations.

I know that many of you are planning to subscribe to a Life Membership. May I urge you to send your pledge card now? We believe that the success of the Depot project and the community need for the Center do merit your endorsement.

Many thanks to the many whose efforts have made the Depot a reality.

When Margery Stoneman Douglas took the podium to address the Historical Society on April 16, the usage of the renovated Depot reached its millenium. How appropos that the County's Historical Society, dedicated to the understanding and preservation of the past, should be the group which used the Cultural-Civic Center for the 1000th time since its opening.

Six years ago the Depot was in wrack and ruin, only a warehouse for railroad supplies and the dusty headquarters of a lumber company. But Emilio Galagarza and the Jaycees saw its potential for the future. They took their cause to the people, crying "Save The Depot."

Old timers realized that most of the landmarks were being razed, with only a few remaining. The City Fathers rallied behind the clarion cry and urged that steps be taken to preserve this vestiage of the past.

In January, 1976, Southwest Heritage was chartered as a non-profit body to raise money to buy and refurbish the old railroad station. Its first task was to determine the way in which a restored building could best serve the community. The Directors concluded that Naples has no greater need than a cultural-civic center at which the 150 or more clubs and organizations might meet.

So with more determination than many thought warranted, this small band of visionaries ventured upon the task of raising \$788,000 to buy and rebuild the decaying structure in order to "preserve the past and prepare for the future."

The fabulous way in which the citizens rallied is well known. Not only was the goal over-subscribed, but special gifts were secured to add a much-needed art center, to purchase three railroad cars which authenticate the project, and to buy a strip of land for required parking.

Now, a year and four months after the opening, few if any would question the rightness of the undertaking. A casual study of the accompanying usage chart corroborates this conclusion. The large Dellora and Lester Norris Hall, seating over 250, has already welcomed more than 200 different groups. The Bradley Gallery to its North has been the display area for fifteen exhibitions, with scarcely a week passing in the season in which some artistic show could not be seen and enjoyed.

The old baggage room, now the Conrad Windisch Room, has been the gathering place for 362 meetings. This light and cheery room, seating up to 75 or so, is in constant demand by varying groups. Adjoining Windisch is the Paul Benedum Room which accomodates small gatherings of about 20 people. Since the James Brooks Room has been assigned to The Naples Institute, the Benedum Room is increasingly in demand. As the months pass, one may find that it becomes the most occupied part of the building.

By chance rather than design, the old Depot has three kitchens, each in a different section of the building. With the heavy demand for parties and dinners, their availability has proved most convenient. Parenthetically, once the Godfrey Patio has been completed, the Board expects the need for the third kitchen will grow.

The railroad cars have likewise played an important role in the life of the Center. Opened to the public only last fall, the Hirshorn Club Car has offered a novel environment for meetings as well as cocktail parties. Its potential is still to be achieved as month by month it grows in demand.

These fifteen months of operations have not been devoid of surprises. None anticipated the constant demand for meeting space which has come from the business community. Hardly a week passes without some financial house or investment firm or business renting space for a seminar or training session. The larger rooms have been equally popular for buffet and dinner parties, most of which are catered. Frequently these are dinner dances, a type of party for which Norris Hall is ideal.

Numerically speaking, the millenium has been passed in fifteen short months. Don't be surprised if one year from this Spring THE WHISTLESTOP reports that double the number of organizations have met at the old Depot in just one year. What a thrill this continuing progress is for the many who have invested their time, gifts and talents to the project. The Depot has truly been saved. And its service as a historical landmark grows.
